



State aid de minimis declaration

Further information about de minimis aid and public funding can be found in the scrappage scheme terms and conditions.

Important information before you start

TfL is considering giving the Recipient (as defined in the Terms and Conditions) de minimis aid under Commission Regulation (EC) No. 1407/2013 of 18 December 2013 on the application of Articles 107 and 108 of the Treaty on the Functioning of the European Union to de minimis aid (OJ L 352 (“the Regulation”) up to a maximum Grant Payment of £15,000 applicable Euro/Sterling exchange rate as set out at http://ec.europa.eu/budget/contracts_grants/info_contracts/inforeuro/index_en.cfm at the date that TfL confirmed in writing that an offer of an Grant Payment has been made in relation to the Scheme.

Under the Regulation, TfL is required to check whether the Recipient will have received or is expecting to have received more than €200,000 (€100,000 for undertakings in the road freight transport sector) of de minimis aid (e.g. public financial support) within the Member State in question (i.e. the UK) in this fiscal year (based on your accounting year e.g. by reference to the Recipient’s accounting reference date) and in the previous two fiscal years when combined with the maximum sum detailed above which TfL is proposed as a maximum to provide as de minimis aid.

De minimis aid includes not only grants but also assistance such as free or subsidised consultancy services, marketing advice etc.

Please note if you as the Recipient are part of a group of companies your declaration needs to relate to funds received (or expected to receive) by all entities within that group for these purposes.

Please note the Recipient does not need to include funding that it may have received under a scheme or individual award which has been notified to and approved by the European Commission or under the State aid General Block Exemption Regulation, unless such funding has been/is intended to be use by the Recipient in relation to the same costs as the proposed de minimis funding from the TfL.

Please note if the Recipient has previously received funding under this Scheme, this should be included in this declaration.

Who must complete the declaration:

- If you or one of your group companies has received any de minimis aid or public funding in the current or preceding two financial years, you must complete this form and include it with your scrappage scheme application submission.
- If you or one of your group companies expects to receive any de minimis aid or public funding in the current financial year, you must complete the form and include it with your scrappage scheme application submission.
- If you or one of your group companies has not received any de minimis aid or public funding in the current or preceding two financial years, you can disregard this form.

TfL require this information to check that TfL’s support added to that previously received or expected to receive, will not exceed the threshold of €200,000 (€100,000 for undertakings in the road freight transport sector) over a three year fiscal period.
